

ONLINE DELEGATE REGISTRATION TERMS & CONDITIONS

1. Following terms and conditions set rules for online registration to the XVIIth edition of Poland & CEE Retail Summit 2026 (summit) to be organized on **14 - 15 April 2026** by European Conferences United Sp. z o.o., with its seat in Kraków 30-331, ul. Ludwinowska 7/16, entered into the Register of Entrepreneurs kept by the District Court for Kraków, 11th Commercial Department of the National Court Register on 15 November 2002 under the KRS number 0000132734 and tax identification number (NIP) PL 6762228354 (hereinafter referred to as organizer) and terms and conditions of participation in the summit.

4. The price covers unlimited access to all sessions/ stages, networking zones, evening gala, conference materials and food during coffee & lunch breaks, dinner and award ceremony for the registered participants.
5. The applicant will receive a Pro Forma (PF) invoice within 2 working days after completing online application form to e-mail address of the applicant or other e-mail address specified in online application form.
6. The person filling out online application form on behalf of the applicant declares that they possess the relevant authorization to act in the name of and on behalf of the applicant, specifically to conclude an agreement with organizer.
7. The applicant should pay summit registration fee no later than 7 days of the issue of Pro Forma (PF).
8. **In the case of registration to the summit before 31.12.2025 and failure to pay early bird price before 28.02.2026, the participation fee amounting to 900 euros + 23% VAT per person shall be charged.**

10. The applicant has the right to resign from participating following the terms and conditions indicated below. Resignation from participation should be made and sent by e-mail to **finance@conferences-united.pl**
 - 10.1 In the case of resignation until **31.12.2025**, the applicant is obligated to pay a service fee in the amount of 250 euros + 23% VAT for every resignation.
 - 10.2 In the case of resignation after **31.12.2025**, the applicant is obligated to pay the full participation fee, in the amount resulting from the agreement concluded between the applicant and organizer.
 - 10.3 In the case of lack of written resignation from participation in the summit, the applicant is obligated to pay the **full participation fee** in the amount resulting from the agreement.
11. Default in payment shall not be unambiguous with resignation from the participation.
12. A person indicated by the applicant (from applicant's company / organization) may participate in the summit in lieu of the person submitted to participate.
13. The summit is planned to be organized in a physical format only and all registrations shall be considered for physical participation only.
14. Due to any reason if the summit is postponed or cancelled (including force majeure) from the planned date of 14 – 15 April 2026, the organizer shall return the summit participation fee in full within 30 days from the planned date of the summit. In such a scenario, Clause 14 shall override clause 10, when the applicant has not paid participation fee and the applicant shall not be liable to pay participation fee moving further.
15. Any disputes arising from this contract need to be filed in the local court of the city in the seat of registered office of the organizer.
